Terms and Conditions

- Daily rate includes limited free milage, please contact the office for additional milage charges
- One time cleaning fee charge of \$13.50 per each rental.
- Must be 25 years of age to drive, all others must be pre-arranged with management.
- There will be \$35.00 processing-fee for any unpaid parking violation ticket in addition to the violation amount.
- One-day rental charge will apply if a "no show" or cancellation is made in the same day of rental date.
- Most cars come with a full tank gasoline, please return the car with a full tank, otherwise a charge of \$5.50 per gallon will apply.

Lessor's policy DOES NOT provide any liability insurance for Bodily Injury, death or Property Damage For the Lessee or other designated driver on this agreement. Lessee or other designated Driver; **MUST (1)** Has available insurance or self-insurance, whether primary, excess or contingent, the Lessor's personal policy might provide coverage only up to the minimum financial responsibility limit required in the State in which the loss occurred. Lessee rejects uninsured, underinsured, supplemental personal injury protection, and no-fault coverage.

WHERE PERMITTED BY LAW, LESSOR HAS ELECTED NOT TO CARRY UNINSURED AND UNDERINSURED MOTORIST COVERAGE. Where Lessor is required to provide such insurance, Lessee is afforded the minimum limits required by law. Lessor does not cover any liability imposed by worker's Compensation or similar statute. You must call the policy immediately to scene of any accident involving the vehicle and make a written report of any accident to Lessor no later than 24 hours after the occurrence or after termination of this agreement, whichever is earlier. You must cooperate with Lessor's insurance company. Any breach of this agreement will void any insurance coverage.

Full Coverage Waiver

By initialing **DECLINES**, RENTER accepts responsibility for all damage up to the full value of the vehicle. By initiating **ACCEPTS**, RENTER agrees 1. To pay the daily rate 2. RENTER has received oral notice that this packaged waiver is optional and may be duplicative of insurance coverage provided under RENTERS own policy.
